SATHI Foundation IIT Kharagpur was set up in 2021 under the Section 8 not profit company Act 2013 for operation and maintenance of the scientific and analytical facilities installed in the "Sophisticated Analytical and Technical Help Institute" (SATHI), set up by the Department of Science & Technology (DST), Government of India at IIT Kharagpur. The SATHI is a shared, professionally managed, national science & technology infrastructure facility. The SATHI Centre at IIT Kharagpur accessible to the Academia, Start-ups, Manufacturing Units, Industries, MSME (Micro, Small & Medium Enterprises) and R&D Laboratories. The Centre houses several state of art analytical and characterisation facility, which can be used by the external users, and also help the users in meaningful interpretation of the results.

The SATHI Foundation, IIT Kharagpur invites online applications from the Indian Nationals and the OCI Cardholders for the following post on a purely contractual basis.

The qualification, experience and age limit for the above post is as under:

Chief Operating Officer (COO)

Pay: Consolidated pay between Rs 1,30,000/- to Rs 2,00,000/- per month (to be fixed during appointment based on qualification and experience) plus other allowances as admissible, as per SATHI Foundation norms for contractual employees.

Job Description: The COO will be responsible for operation, maintenance, publicity, outreach, and all other activities, including day to day operations of SATHI Foundation IIT Kharagpur. Other employees of SATHI Foundation IIT Kharagpur including instrument operators will report to her/him. The COO will be responsible for independently reaching out to Industry. For details about job responsibilities, please refer to Annexure 1.

Nature of Job: Contractual. Initial appointment will be for one (1) year which can be extended up to 3 years on yearly renewal basis based on evaluation of satisfactory performance. Extension of contract beyond three (3) years may be considered based on the performance of the COO, if the Centre becomes financially self-sustaining.

The COO will report to the Chairperson, SATHI.

Essential Qualification and Experience:

- Post-graduate in Science/Engineering or M. B.A. or Ph.D in any natural science stream with first class (a minimum of 60% marks or CGPA of 6 out of 10) or equivalent at all the preceding degrees.
- Prior experience in C-Level roles (COO, CEO, CTO, CBDO, CMO, or equivalent) in technology-driven entities: academia-based organizations, private sector companies, NPOs.
- Proven track record in leadership roles with the key focus on customer development, stakeholder engagement, and new markets acquisition, preferably within research facilities, academic institutions, or technology-driven organizations.

Desirable Qualification and Experience:

- Strong Industry connect.
- Strong strategic planning and decision-making abilities.
- Excellent financial acumen and business development skills.

- Ability to engage and collaborate with government agencies, industries, and academia.
- Demonstrated leadership in team development and operational excellence.
- Idea about accreditation of Instruments.

Maximum age limit: Preferably below 60 years as on the closing date of application.

Essential Qualification criteria can be relaxed for candidates with Exceptional candidates (particularly in terms of experience)

General Instructions

- 2. No fee shall be paid at the time of application.

- 6. Initial appointment will be for one (1) year which can be extended up to 3 years on yearly renewal basis based on evaluation of satisfactory performance. Extension of contract beyond three (3) years may be considered based on the performance of the COO, if the SATHI Foundation, IIT Kharagpur becomes financially self-sustaining.
- 7. The SATHI Foundation, IIT Kharagpur reserves the right to empanel candidate(s) for future vacancies.
- 8. Candidates should submit their SC/ST/OBCs/Disability Certificate issued by the Competent Authority in the prescribed format along with the application form, in support of their claim.
- 9. Degrees as referred above should have been awarded by a recognized University/Institute.

Expected Roles and Responsibilities of COO SATHI Foundation

This short writeup will give the applicant an idea about what is expected from the Chief operating officer of SATHI Foundation, IIT Kharagpur.

Background:

SATHI (Sophisticated Analytical & Technical Help Institute) is a flagship Scientific Infrastructure Development program of the Department of Science & Technology, Government of India. IIT Kharagpur was invited to set up a SATHI center in December 2018 (along with 19 more Institutes). After several rounds of rigorous evaluation, three Institutes were chosen for setting up of the First three SATHI centers, which are: IIT Delhi, IIT Kharagpur and BHU.

As a part of the SATHI grant, we got three major Instruments, which are: 1) Double aberration Corrected HRTEM, 2) Time of Flight Secondary ion Mass Spectrometer (ToF-SIMS) and 3) A high temperature environment controlled creep testing machine. The instruments are operated by dedicated operators. There is a Professor in charge for each instrument, who render their advise and services entirely on an honorary basis. The applicants are requested to visit the SATHI website: https://sathi.iitkgp.ac.in/ for more details.

DST desired that the activities of the SATHI center should be managed and run by a Section 8 company, and consequently, the company was incorporated in April 2021. Based on an MoU with IIT Kharagpur, the SATHI Foundation is entrusted to run the instruments and charge testing charges to the users. The Director IIT Kharagpur is the ex-officio CMD of the SATHI Foundation.

The office hours are between 9.00 AM and 6 PM, Monday to Saturday.

The primary responsibilities the Chief Operating Officer will be (but not limited to):

- 1) The COO will report to the Chairperson, SATHI who is a faculty member of the Institute, and will be nominated by the Director, IIT Kharagpur.
- 2) Monitoring the day to day activities of the Company, including overseeing the attendance of operators, ensuring operation efficiency of the equipment and auxiliary systems, allotment of slots to users (both from IIT Kharagpur and outside, including industry and startup). This step will require detailed coordinator with the Professor in charges of each facility.
- 3) Follow up on the payment towards testing charges and generation of invoice, using the dedicated ERP facility available for SATHI Foundation, IIT Kharagpur.
- 4) Strategize earning around the instruments, so as to make the company self-sustaining by generating revenue.
- 5) To ensure purchase of consumables and accessories, following the GFR, for smooth running of the instruments. In certain cases, the COO has to assist the Chairperson in procurement of some permanent equipment, which might have to be acquired from time to time.
- 6) To synergize with other units of IIT Kharagpur such as Central Research Facility, Advanced Manufacturing Center and so on, where advanced instruments are housed, so that the external users who approach SATHI can also get their testing done in instruments that are installed across IIT Kharagpur (outside SATHI).
- 7) To reach out on a priority basis to other academic institutes, industry and SME to make them aware about the activities of the Company and the facilities available, to increase the user base. This

may require travel by the COO. Priority for SATHI Foundation IIT Kharagpur is to reach out to Industry and MSME.

- 8) To work towards accreditation of the Instruments by NABL or similar agencies.
- 9) To regularly and routinely organize workshops (at IIT Kharagpur and also at other locations) for awareness, training and skill development.
- 10) Register the instruments in the National Instrument portal, i-STEM.

The above points are just for giving an idea about your roles and activities to the applicants. The COO will be responsible for the smooth, seamless operation of the facilities, revenue generation and all other aspects.
